

# SECTION 4 : First aid measures

## Description of first aid measures

**After inhalation:** Loosen clothing as necessary and position individual in a comfortable position. Move exposed to fresh air. Give artificial respiration if necessary. If breathing is difficult give oxygen. Get medical assistance if cough or other symptoms appear.

Suitable extinguishing agents: Use appropriate fire suppression agents for adjacent combustible materials

Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Evacuate personnel to safe areas.
