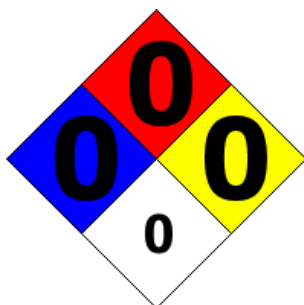

SECTION 4 : First aid measures

Description of first aid measures

After inhalation: Loosen clothing as necessary and position individual in a comfortable position. Move exposed to fresh air. Give artificial respiration if necessary. If breathing is difficult give oxygen. Get medical assistance if cough or other symptoms appear.

After skin contact: Rinse/flush exposed skin gently using soap and water for 15-20 minutes. Seek medical advice if discomfort or irritation persists.

SECTION 5 : Firefighting measures

Extinguishing media

Suitable extinguishing agents: Use appropriate fire suppression agents for adjacent combustible materials or sources of ignition. Use water, dry chemical, chemical foam, carbon dioxide, or alcohol-resistant foam.

For safety reasons unsuitable extinguishing agents:

Special hazards arising from the substance or mixture:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors.

Advice for firefighters:

Protective equipment: Use NIOSH-approved respiratory protection/breathing apparatus.

Additional information (precautions): Move product containers away from fire or keep cool with water spray as a protective measure, where feasible. Methods and material for containment and cleaning up:

Keep in suitable closed containers for disposal. Wear protective eyewear, gloves, and clothing. Refer to Section 8. Always obey local regulations. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Evacuate personnel to safe areas.

SECTION 7 : Handling and storage

Precautions for safe handling:

Follow good hygiene procedures when handling chemical materials. Refer to Section 8. Do not eat, drink, smoke, or use personal products when handling chemical substances. Avoid contact with eyes, skin, and clothing.

Store away from incompatible materials. Protect from freezing and physical damage. Keep away from food and beverages. Provide ventilation for containers.
