

SECTION 4: First aid measures

Description of first aid measures

Extinguishing media

Suitable extinguishing agents: Use appropriate fire suppression agents for adjacent combustible materials or sources of ignition. Use water, dry chemical, chemical foam, carbon dioxide, or alcohol-resistant foam.

Special hazards arising from the substance or mixture:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors.

Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Evacuate personnel to safe areas.
